Security and Issuer. Item 1.

This statement relates to the common stock, par value \$0.01 (the "Common Stock") of Ross Stores, Inc. (the "Company"). The Company's principal executive offices are located at 4440 Rosewood Drive, Pleasanton, California 94588-3050.
